Our policies and procedures

We have appropriate policies and procedures in place that underpin our commitment to mitigate the risk of modern slavery or human trafficking in our supply chains or in any part of our business. We continuously review and update all our policies.

Due diligence processes

We will undertake due diligence to identify and address risks, which may include:

- conducting due diligence questionnaires/assessments for potential suppliers;
- identifying and taking a record of our supplier's Modern Slavery Statements and/or commitments to maintaining an ethical supply chain free of modern slavery; and/or
- reassessment and performance reviews of existing suppliers, in particular those in high-risk areas.

Where we consider that the sector in which a supplier operates as being regarded as having a higher risk of potential for modern slavery in their supply chain, we ask for additional information about the steps they have taken to eliminate modern slavery in their supply chains.

Supplier adherence to our values and ethics

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we include robust anti-slavery clauses in our supplier agreements.

In the performance of their contract with us, we require that our suppliers comply with the Act and immediately report to us any suspected or actual breach of the Act.

Training

To raise awareness of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to our staff. We encourage all our staff to report any concerns or suspicions of inappropriate or illegal behaviours in our supply chains in accordance with our Whistleblowing Policy.

Measuring our effectiveness in combating modern slavery and human trafficking

We use the following key performance indicators to measure how effective we have been to ensure that slavery and human trafficking is not taking place in any part of our business or supply chains:

- Ensuring increased supplier due diligence incorporating modern slavery and human trafficking is carried out in relation to 100% of key suppliers onboarded, or as part of our scheduled on-going supplier governance reviews.
- Assessing outcomes from supplier assessments and due diligence.
- Number of concerns or suspicions raised via whistleblowing or other channels related to modern slavery and human trafficking.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our slavery and human trafficking statement for the financial year ending 31 September 2025.
